on June 7<sup>th</sup> - John Ellis a well known ranchman, was going out to his herd in company with three of his herders and several other cowboys engaged in the annual roundup.

They heard a terrific rushing, roaring sound overhead, and looking up, saw what appeared to be a blazing meteor of immense size falling at an angle to earth. A moment later it struck the ground out of sight over a bank.

Scrambling up the steep hill they saw the object bounding along half a mile away and disappear in another draw.

Galloping towards it with all their speed, they were astounded to see several fragments of cog-wheels and other pieces of machinery lying on the ground, scattered in the path made by the aerial visitor, glowing with heat so intense as to scorch the grass for a long distance around each fragment and make it impossible for one to approach it.

Coming to the edge of the deep ravine into which the strange object had fallen, they undertook to see what it was. But the heat was so great that the air about it was fairly ablaze and it emitted a light so dazzling the eye could not rest on it for more than a moment.

Finding it impossible to approach the mysterious visitor, the party turned back on the trail. Where it first touched the earth the ground was sandy and bare of grass. The sand was fused to an unknown depth over a space of twenty feet wide by eighty feet long, and the melted stuff was still bubbling and hissing.

The next morning another visit was made to the spot. The smaller portions of the scattered machinery had cooled so that it could be approached, but not handled. One piece that looked like the blade of a propeller screw of a metal of an appearance like brass, about sixteen inches wide, three inches thick and three and a half feet long, was picked up by a spade. It would not weigh more than five pounds, but appeared as strong and compact as any known metal.

The aerolite or whatever it is, seems to be about fifty or sixty feet long, cylindrical, and about ten or twelve feet in diameter.

Now it gets stranger. On June 9<sup>th</sup> 1884 the Nebraska State Journal reports:

“Your correspondent has just returned from the spot where the aerial visitor fell last Friday. It is gone dissolved into the air. A tremendous rain storm fell yesterday afternoon beginning around 2 o'clock. As it approached, in regular blizzard style, most of those assembled to watch the mysterious visitor fled to shelter. A dozen or more, among them your correspondent, waited to see the effect of the rain upon the glowing mass of metal. The storm came down from the north with a torrent of rain. It

lasted a half an hour, and when it slackened so that the aerolite should have been visible it was no longer there. The draw was running three feet deep in water and supposing it had floated off the strange vessel, the party crossed over at the risk of their lives.

They were astounded to see that the queer object had melted, dissolved by the water like a spoonful of salt. Scarcely a vestige of it remained. Small, jelly-like pools stood here and there on the ground, but under the eyes of the observers these grew thinner and thinner till they were but muddy water. The air was filled with a faint, sweetish smell.

The first sightings started on the night of March 29, 1897, in Omaha with more than a 100 people witnessing the appearance of a flying object approximately 12 foot long, spherical in shape, shiny with a steel-like body. The term UFO had not been coined at this time.

The reports said the object became so luminous that the brightness awakened people from their sleep as the light flooded through their bedroom windows. Many of the witnesses went into a panic.

Several nights later, in Sioux City Iowa, another craft cigar-shaped, attracted more attention from the people there.

Similar sightings that night were reported in Cedar Rapids and Burlington Iowa. The mysterious object was reported to be elongated with a glaring headlight of some kind and a shiny steel hull, gliding along with a “hissing” sound.

On April 17th, there was the famous Aurora Texas crash of an airship. The dead occupant of the craft was buried by the town folk. There were a lot more individual sightings in the Aurora, Denton, and Dallas area over a week in April than were reported over the entire summer in other areas of the country. There were several reports of the aeronauts actually talking to the witnesses. They were not alien but were normal earthlings. Almost all the sightings were made during the night with a few during the day. There were as many as three different objects based on witness reports.

On June 3<sup>rd</sup> 1920 the witness decided to go fishing and around 10:00AM he spotted an object around the size of a five gallon ice cream can that was turtle shaped. It landed around fifteen feet from him on the river bank. It sat there for about fifteen minutes without bothering him or he bothering it. He said he was not in a hurry to jump up and run over to it. He said that if he did it might have killed him. Just when he thought about going over to it, it took off without any sound and without turning around. The grass where it landed was pressed down. He described it as shiny blue and translucent. He concludes that it was nothing from planet Earth.

Driving near Kearney, Nebraska near an old sand bar on the Platte River, within 100 ft of the river his car stalled. He got out to investigate and noticed what he later described as a 'Half filled Balloon'. He approached the object and getting within 30 ft noticed that it was a metallic craft. It was resting on four hydraulic rams serving as landing gear. A door slid open and two men came out and invited him in to see the craft, but warned him not to touch anything. The main operations area was around 50 ft long and there were four additional rooms serving as bedrooms, kitchens, and a garage for an MG. The walls were around 1 ft thick and looked glassy. From inside the craft you could look outside, but from outside the craft it was opaque and looked like polished aluminum. There were no portholes or windows only a doorway and a car ramp. A pleasant light seemed to radiate from the walls and the temperature was also constant. They told him the craft could be used for interplanetary travel and could travel on or below the sea. The main room was filled with clocks, dials, buttons, and switches. In the center was a large viewing screen that the crew members were busily watching. Mr. Schmidt was amazed at the way the men seemed to glide instead of walking when backing away from their instruments. Halfway up the wall at each end of the ship was an hour glass shaped object that were the power units for the craft. Mr. Schmidt was told that they got their energy from the sun and the earth. All the crew members both male and female had long black hair and appeared to have tanned skin. The men were about 5'8" tall and weighed around 170 pounds and the women were also 5'8" tall and weighed around 120 pounds. They could speak any language needed to communicate with whatever earthling they encountered. Mr. Schmidt said that there were four male and two female, who apparently spoke German as their "native" language, but claimed to be from the planet [Saturn](#). "The Saturnians" also claimed to be extremely interested in the recently launched Russian [sputniks](#), and the satellite-launching plans of the US. Mr. Schmidt watched the craft take off at close range. The motor sounded like an electrical one that quieted down as it gained momentum. As the craft gained 12 ft in altitude it turned black. At around 100 ft it turned bluish green and started heading southwest. At a height of around 150 ft it completely disappeared.

Later Schmidt brought local police to view the "landing site," where they found only Schmidt's footprints and some "mysterious green residue"

which matched the contents of a nearly-empty can of motor oil in Schmidt's car. Police also found Schmidt had a record of conviction and prison time for embezzlement. Like almost every 1950s contactee, Schmidt became a "repeater," claiming many visits to the alien space ship and many friendly conversations with its crew. Schmidt noticed they drank MJB brand coffee, and also carried in their cigar-shaped craft an ordinary terrestrial [MG](#) sports car, which they used for running errands and buying groceries. (A schematic drawing of the ship's interior in Schmidt's later booklet depicts a [Volkswagen Beetle](#), not an MG sports car.) Unlike most space ships the [Saturnian](#) ship had large propellers at both ends. Eventually Schmidt got the ride up to earth orbit, and tour of the Mother Ship, that almost all 1950s contactees report.

Schmidt had joined up with [Wayne Sulo Aho](#) and John Otto on their lecture circuit across the US, within two months of his reported "first contact." Unlike the majority of contactees, Schmidt did not seem interested in forming a religious cult, although the Saturnians had the usual Space-Brotherly religious message and revealed that they had been around to help Jesus, a Venusian, in his mission to earth. Schmidt relocated to [Bakersfield, California](#), where he continued to present lectures for the next few years, recounting his other-worldly experiences and later sought out elderly women who had been in his audiences and whose addresses he had obtained. He told them that in his rides in the space ship he had observed the location of valuable mineral deposits, including a unique form of quartz crystal which could cure cancer. Having exhausted his funds in purchasing the site, he now needed quick cash to begin mining the crystals and demonstrating their healing properties. Most of the ladies he approached quickly came up with several thousand dollars a piece to aid his "space-directed" mission. He collected sums approaching \$30,000 before his arrest and conviction on charges of grand theft. Little is known about his later career, except that after his release from prison, he returned to Nebraska.

## SCHIRMER NOTES

Background:

During the summer of 1966, Jacques Vallee heard rumors in Europe that the Air Force was looking for an excuse to dump the UFO problem. They were finding it difficult “to find a university that was willing to write a negative report after a cursory examination of the facts.”

On August 9th 1966, Robert Low, a senior administrator at the University of Colorado and former intelligence officer, wrote to two other university administrators that “The Trick would be to describe the project so that, to the public, it would appear a totally objective study, but to the scientific community would present the image of a group of nonbelievers trying their best to objective but having an almost zero expectation of finding a saucer.”

On October 6th, a contract was formalized with the University of Colorado that a study was to be led by Dr. Edward Condon a world-renowned physicist, assisted by Robert Low. They began the study on November 15th.

### Schirmers Story

Twenty-two-year-old policeman Herbert Schirmer would have a bizarre experience on December 3, 1976. While making his normal patrol rounds in Ashland, Nebraska, he saw what appeared to be red lights atop a large truck. He had checked locations along Highway 6, and just hit the intersection of two highways, 6 and 63, when he saw the red lights. He would get a closer look.

## **Change slide 20**

As he moved on down Highway 63, he came to a stop, and shined his headlights on the red-lighted object. He immediately knew the object was no truck. The red beaming lights were coming through what Schirmer described as "portholes." He could clearly see a disc-shaped, metallic UFO that was hovering about eight feet off the ground. The polished, aluminum object had a type of walkway around its circumference. He could also see what he thought were legs below the object.

## **Change slide 21**

The UFO began to send flames below it, as it rose into the air. Schirmer could hear a siren sound coming from the object as it rose higher and higher. The UFO then passed directly over his police car and flew out of sight. Schirmer sped back to the police station, making a note of the time as 3:00 AM. This shocked him, because he knew he had been on patrol much longer than the 10 minutes the present time indicated. Schirmer made the following entry into his log book:

"Saw a flying saucer at the junction of highways 6 and 63. Believe it or not!"

Schirmer began to experience some physical problems right after his sighting. He suffered from headaches, felt ill, and had a red welt on his neck. The Condon Commission, located at the University of Colorado, and at the time, investigating UFO sightings, heard of Schirmer's sighting, and requested that he come to Boulder, Colorado. On February 13, 1968, Schirmer would undergo regressive hypnosis, administered by psychologist Dr. Leo Sprinkle of the University of Wyoming.

Psychologist Dr. Leo Sprinkle(First Session):

Report findings:

1. The police car stalled or stopped.
2. The headlights went off during the sighting.
3. Schirmer was "prevented" from taking his gun out during the sighting.
4. Schirmer was "prevented" from using his police radio.
5. A bright light was emitted from the object and shone upon the car.



6. Schirmer observed a white blurred object, which came from the object and approached the car. It was apparently an intelligent organism.
7. Some sort of "conversation" with the white blurred object took place by some means of mental communication.
8. Communication with someone in the craft occurred at the time of the UFO sighting, and a feeling of direct mental contact with someone was occurring at the time of the interview with the study group.
9. Information was obtained which indicated that the craft was propelled by some type of electrical or magnetic force which could control the force of gravity.
10. The craft was obtaining a power supply from nearby power lines in order to assist in communication.
11. The craft belonged to a "sister ship," which was like an aircraft carrier.
12. The occupants of the craft were based on Venus or Saturn but were from another galaxy.
13. The intentions of the beings were friendly, and their purpose was to prevent earth people from destroying the earth.
14. Schirmer was told that he was "doing a good job," that he should not talk further during the interview, but he could talk later that year and tell more about the events of the UFO sighting.

Dr. Sprinkle ended his report. "In my opinion the events described by Sgt. Schirmer are „true. in his experience; however, I believe that the present evidence does not answer the questions regarding the source, method, and purpose of communicating the additional information."

The Condon Committee:

The Condon Committee concluded that: "Evaluation of psychological assessment tests, the lack of any evidence, and interviews with the patrolman, left project staff with no confidence that the trooper's reported UFO experience was physically real." Psychologist Dr. Sprinkle, however, felt that Schirmer "believed in the reality of the events he described."

Regressive Hypnosis (Second Session): Change slide

Looking for relief from his psychological problems, he would undergo more regressive hypnosis in June, 1968. Hypnotist Loring G. Williams conducted the sessions, which would reveal many more details:

1. Three telescoping legs on the bottom.
2. An entity standing in front of the cruiser held in its hand that seemed to envelop the cruiser with a gaseous green substance.
3. An entity pointed a device at the windshield and bright flash paralyzed Schirmer and caused him to black out.
4. When he came to one of the entities grabbed him by the neck and caused him great pain. The red welt on his neck.
5. They asked him if he was the watchman over the town? He replied that he was a policeman.
6. He was asked if the nearby power plant was the only source of power for the area, and he answered that it was.
7. He was asked if he wanted to board the craft and when he did they told him it was powered by reversible electromagnetism, which had something to do with gravity.
8. He recalled seeing an inverted but otherwise similar version of the star map drawn by Betty Hill.
9. The entities told him that „they know that they are being seen too frequently and they are trying to confuse the public’s mind..
10. They wore a tight fitting one piece uniform with gloves and boots the uniform had a patch, showing a snake with wings, on the left side.
11. They had a small antenna sticking up from the piece over their right ear.
12. They only eat vegetables and fruits. No meat.
13. The observation craft collected plant and animal samples. He was informed they picked up cows, dead bodies of animals, and some people. These were used for experiments.
14. He said “There were books that looked like log books on the table. They had symbols more like the stuff you see in movies about Egypt”
15. He was escorted out of the craft and walked back to his cruiser as the four humanoids reentered the craft.

#### Schirmer's Personal Problems:

When Schirmer returned to his duties in Ashland, Police Chief Wlaskin resigned, and Shirmer was appointed as new chief. But because of ridicule from the citizens, and the UFO experience, he was not able to rightfully perform his duties, and resigned two months later. Someone had thrown dynamite into his patrol car, and his wife left him during this time.

### **Change Slide 22 June 5<sup>th</sup> 1969**

Three persons at the Cedar Rapids Airport report seeing a blue, circular object with no wings streaking east to west at an altitude less than 1000 feet. They estimated the speed to be 300 to 400 mph. There were other sightings in Iowa that same night from Des Moines to Omaha.

On December 5<sup>th</sup> a witness and her four daughters saw a green flash in a soybean field near Underwood. It reminded her of a flash of lightning followed by an explosion of green.

On December 8<sup>th</sup> four men driving on I-29 around 1:45AM saw a solid crescent of green light that looked as big as a mountain. The sighting lasted for four or five seconds. A Council Bluffs police officer that lives near ISD said that he heard a loud bang like a shotgun outside his window. He looked out and his mercury vapor pole light was out. He thought at first someone had shot it out, but the yard was still lit as if it was still on. The light went out and all was dark and around three minutes later the yard light came back on. The light had a sensor that went out because of the light from the object.

CB Metal Notes: Metal Rain

There was absolutely no question about what happened in Council Bluffs, Iowa, on the night of Dec. 17, 1977. A UFO ejected about 40 pounds of molten metal onto the ground. While most of America was settling down for the evening sitcoms, Mike and Criss Moore, who were each 24 at the time, were driving to Mike's mother's home in Council Bluffs. About a half mile ahead, just above the treetops, they saw a glowing red ball falling toward Big Lake Park. "It hit the ground in the vicinity of Gilberts Pond in Big Lake Park, across the Missouri River from Eppley Airfield. When onlookers arrived at the impact point on a small levee, they found a 4-in.-

thick mass of molten, red-orange metal covering the frozen ground, about 16 ft. from the road. The metal mass was still glowing 15 minutes later when Mike Moore's father, assistant fire chief Jack Moore, arrived.

After the metal had cooled, Robert Allen, a local astronomer, collected samples. Part of the roughly 40-pound slab went to the U.S. Air Force's Foreign Technology Division at Wright-Patterson Air Force Base in Ohio. A portion also went to the Ames Laboratory at Iowa State University. The Air Force never made its analysis public, but in a letter assured local authorities that "re-entering spacecraft debris does not impact the earth's surface in a molten state." In his report, Ames Laboratory director Robert S. Hansen ruled out a meteor.

Officially, the episode remains an unsolved mystery, but Jacques Vallee, a renowned UFOlogist, sees it as something more telling. The Council Bluffs episode was not unique. At the Pocantico conference, Vallee said that in at least nine other sightings, aerial objects in distress were accompanied by the ejection of molten metal. Since earning my doctorate in 1975," he says. "I've learned quite a bit about the UFO phenomenon over the years, certainly more than I had bargained for. UFO sightings are not limited to farmers in backward rural areas. There are astronomers, and pilots and NASA engineers, who have witnessed events for which there is no plausible

### **Original Report**

3 stars all night, same locations all night, until about 330am until around 430 am, would be active with lights and movements, and lit up ground above our farm and neighbors acreage.

### **Investigators Report**

Saturday, August 4, 2007

At mid morning down by the west part of the coops the witness was cleaning out the outside holding pen with a garden hose. The witness said she felt that something was watching her. She turned around and was nearly face to face to the creature looking through the fence at her. She described the creature as about 2 – 2 ½ feet high, big glossy black eyes and was green with semi transparent gray wings. She said she was scared and slowly backed away and made her way to the house to get a camera. When she got to the window the creature was gone. The witness then took a panoramic shot of the backyard. She then went back outside, she pick up the garden hose to put it away when she hears rustling in the bushes on the north side of the coop a swooshing sound.

She sprayed water on it and started to run toward the driveway(about noon). At about two in the afternoon the witnesses friend came over to visit and found the witness on the ground. The witness had a V shaped bite on her arm along with a puncture, there were also lots of black bruise marks all over her arm which disappeared the next day.

Foot prints were found in the garden area and claw marks on a post. The witness made a drawing later that day. ( We took a picture of a re-created foot print in the same area to try and get an idea of size and perspective. The re-created print was made by the witness. ). Several weeks later 30 - 40 feet from the main yard the witness found a chicken leg wedged in a nearby tree.

Bigfoot Notes:

DATE: January 1974

The witness walked out to the driveway to see friends off about 2:20MA and saw a shadowy form moving between some cases in the driveway. He paid no attention as he thought it was dogs. He went back into the house and a few minutes later heard a high shrill scream very loudly. He grabbed a 30-30 deer rifle and hurried outside. There illuminated by the snow was a big hairy creature estimated to be seven feet tall. When it was about 75 feet away he shot it. It was knocked backwards and fell to the ground. By the time he was able reload it was gone. The following morning no tracks could be seen as horses had been in the same area. Some blood was on the snow.

DATE: August 28<sup>th</sup> 1974

The witness was awoken by his dog in the back entryway barking. He then heard the loose railing on the back porch rattle. He observed an upright hairy biped six feet south of the bedroom window. It was turned with it's left side toward the witness. It's right shoulder was lower than it's

left. It slowly walked around the corner of the garage with a shuffling gait. It has a pointed head and a somewhat stooped stance. It had hair all over and estimated it was at least 200 lbs. There were footprints on the wet grass estimated to be around 8 inches wide.

DATE: early fall 1974

LOCATION: While traveling southbound on highway 77, near Blue Springs, Nebraska, I encountered a very large bi-pedal creature. As I came around a gentle left curve in the road, this creature stepped up out of the ditch on my side and with one stride was upon the road bed and with two more strides was across and going down into the ditch on the other side. I was most impressed with the girth of the creatures legs, and torso, it was massive and about 7-8 feet in height, I would estimate the weight to be 6-700 pounds, the body was covered in medium length blackish brown hair, and the face appeared to be less hairy.

DATE: 06/02/1980

LOCATION: Nebraska, Dawes County

OBSERVED: Ten and 1/2 foot standing animal. It was black, with long hair, no neck, looking towards us standing in a beam of light in a stand of timber with shadows all around.

WHEN: 1992-1993

WHERE: Two lane highway in the Sandhills of western Nebraska.

ACTIVITIES OF WITNESSES: The two men were hauling a load of cattle down the highway to a cattle show/sale. It was very late at night. The driver thought his friend in the passenger seat was sleeping. All of the sudden a "big hairy thing" ran out in front of them. "What the hell was that!" The driver yelled. Both assumed it was a Bigfoot. "We were very scared. I hit the gas and got the hell out of ther ."

#### **Cattle Mutilations:**

Cattle mutilations in Nebraska have been going on for quite some time. In the mid 70's ranchers use to patrol at night as groups using CB radios. At that time there was speculation that this was some kind of occult practice.

Larry Jurjens was checking his herd of about 100 cattle" Thursday, August 19, 2004 "when he found a dead 11-year-old Black Angus. Jurjens said the cow's left eyeball was removed, the bag and udders had been removed, and there was a large excision in the rectal region. None of the internal organs were removed, and he said the cuts appeared to have been made with surgical precision. Jurjens, who has been a rancher" in Farnam, Nebraska "for more than 35 years, said he has never seen anything like it before. Jurjens said no blood was found on or near the cow. The cow's death was investigated by Linda Moulton Howe, an international investigative journalist and documentary film.

In Farnam, Nebraska on August 18th and 25th, 2004, two cows were found mutilated in different pastures. There was no sign of struggle as in the animals putting up a fight. The cows had their blood drained, tongues, eyes, hearts, sexual organs removed. Tests around the cows revealed there was large concentrations of magnetite (IRON OXIDE-BLACK CRYSTALIZED FORM)) on the plants, hides, and ground.

February 20, 2010 – Omaha Area

I went onto my front porch for a smoke and noticed a cluster of lights just west in the sky over Hobby Lobby. I thought it was an awful lot of helicopters in one group.

Then I noticed the lights weren't on machines and the color was gold. At the same time I turned my head a little north and saw a kind of lantern shape pale reddish in color on the inside and goldish skin like a balloon. I thought: How do they keep candles burning inside a balloon? The effect was exactly like candlelight. It was beautiful. Meanwhile the lights were heading SW and as they got further away they appeared like gold from a sparkler but without the flashing got smaller and smaller and I couldn't see them anymore. One went straight up into the clouds and went transparent when it touched the cloud.
